Thank you for your interest in becoming a Kiddie Kare Caregiver.

Kiddie Kare is a licensed agency. We ensure that the standards set out in the Day Nurseries Act are met and followed. The agency provides caregivers with the necessary forms, major equipment (as required), and a back-up service for holiday and sick days. We train you prior to your first placement and offer you information and seminars to update your skills. We expect at least a one-year commitment from our caregivers to ensure the consistent care of the day care children.

We pay for statutory holidays, and the child's sick days, with monthly cheques that are sent to your home. We offer liability insurance, newsletters, craft supplies, toy lending and the opportunity to borrow from a vast library of information. When you begin caring for a child placed through our agency, you will receive a caregiver start up kit, to help you get under way.

We will visit your home with monthly-unannounced home visits. A written report will be left in your home and one will be left for you to forward on to the parents. During these visits, our staff will be available to help you with any concerns you may have. They will also bring you activities from time to time.

You will be expected to follow the rules set out by the agency pertaining to the care of the children and the number and ages of children to be cared for. This can include no more the 5 children under 6 years of age, 3 under 3 years, or 2 under 2 years, including the Caregiver's own children. You are required to have a medical and to ensure KIDDIE KARE that all members of your household have an up to date immunization. We also require a criminal reference check on all members of the household over 18 years of age. (This must be submitted to the agency prior to interviews)

As there is a waiting list of several months, your application should be returned immediately. Upon receipt and review of the medical and reference forms, we will contact you to assess your home and notify you of the need for Caregivers in your area.

Thank you for your interest. We look forward to having as part of the KIDDIE KARE TEAM and establishing a rewarding association in the near future.
